(e) Centre for Excellence Mr Richards reported that Mr Spooner had taken a new job which would cause him to move out of the region. The meeting asked Mr Richards to write to Mr Spooner giving their thanks for all the work he had carried out in the region both with Speedwell Volleyball Club and at the South West Centre of Excellence.

Mr Reynolds explained that the funding of the centre of Excellence was to be passed to the National Association and the new approach to Grand Aid. Further the South West Sports Council would not be able to provide a continual grant after April 1986. although some of the activities of the centre might be grant aided for specific purposes and periods.

Mr Richards agreed to take up with Mr Eulman the issue of National funding and in particular the problem of the payment of the second half of this year.

Mr Richards proposed that the centre should continue to operate for the season 1986/87 using the following sources of payments

a) Support from the EVA through the new grant aid.

h) Support from the South West Sports Council for the Junior project initiated at Fatchway School as part of Centres funding

c) The remaining funds in the Centre of Excellence account.

Discussion took place and it was agreed that this should happen as long as funding did not need to come from the normal South West Accounts.

There was further discussion on the future need for activities such as the Centre of Excellence and Mr Jones felt that there was a need to improve the coaching of coaches within the areas. On the advice of Mr Reynolds it was agreed that the South West should seek the Sports Council help in the following ways.

a) the development of excellence - this would need regional staffing and could take placelat specific weekends - (perhaps tied in with a tournament such as Britannia)

b) Advisary support for coaches

c) evelopment - top coaches to go out to the developing areas to take coaches and player performance courses for developing AREAS.

(f) Competitions The meeting was concerned at the absence of Mr Loke and in addition the absence of a competitions report Discussion took place on the South West Championships and in particular on the clash with Superbowl which caused a number of protlems in the provision of referees. The meeting felt that it was reasonable that the closing date should be March 31st and also that Mr Jones should contact Mr Loke on April 1st for a definite answer on the number of referees that he would have to provide.
