#### 2. Minutes

The minutes of the meeting held on 21st January were agreed as a true record with the amendment of Mr Williams initial from "B" to "D".

### 3. Matters arising

Sponsorship - Mr Richards reported on his contact with a Sports Consultancy which as yet had brought no results.

#### 5. <u>Development Plan</u>

Mr Richards led a discussion on the items included in the development plan for 1989/90:

Structure - it may be better to look at Somerset and Dorset for county status rather than Avon and Devon.

Development Officer - Mr Richards to put a paper before EVA Resources and General Purposes Committee.

Equipment - Miss Hooper to check on number of balls held by the squads.

Development Centres - need for a officer to carry out the organisation to help Mr Swann.

Referees - concern at lack of input from the Referees Secretary.

Competitions - Mr Giddy to be asked to write to county / area secretaries to judge support for a SW County Championships.

Womens Development - agreed to fund development in Dorset and Glos once their development plans had been approved by Mr Richards.

Junior Development - Mr Dingle had asked the meeting to draw up a list of priorities. It was agreed that he should be asked to work with area officers to set up courses for teachers in as many areas as possible and that plans should be made for junior competitions to be organised as local rounds of national competitions in conjunction with the S & JD Commission. Points were also made later in the meeting concerning the Junior Squads.

Budget. It was agreed to allocate SWVA moneys to budget headings as

Development Centres £200
Junior Squads £500
Administration £100

All invoices to be paid by Mr Insley on receipt of an invoice, as long as the item has appeared in the budget for that activity.

#### 6. SW Championships

Date of senior championships to be amended to May 19/20th 1990.

No requests to host the championships had been received. Mr Francis to investigate possibilities of the use of Chippenham / Melksham.

Ladies Introductory - Miss Stone to be asked to book venues for two dates & to pass those dates to Mr Richards and Mr Giddy. Suggested that those two tournaments take place in Glos and Dorset (as per Development Plan).

Inter Area - Mr Giddy to be asked to book venues and dates. agreed that a new ruling be applied - no more than 2 currently registered national league teams to take part in any team.

Mens beginners tournament - Mr Richards to check with Mr Jones re the hosting of this new event in Dorset. There was also a possibility of a second tournament being offered in Woodspring.

Mr Giddy to be asked to coordinate the dates of the above events.

U12/U14 Mini Volley - Mr Cross offered to run this in Woodspring.

- a) Secretary Mr Richards reported encouraging trends in affiliations and was desperate for newsletter articles.
- b) Treasurer Mr Insley reported the current financial situation in his written report.
