5.Officers Report

The following were received in the written annual report:

- a) Chairman Mr Williams asked Mr Dingle to clarify his written comments about the decline in womens volleyball. Discussion took place and there were doubts expressed about Mr Dingles opinion.
- b) Secretary items concerning the 25th birthday of the Association and the newletter deferred to AOB.
- c)Treasurer a set of accounts and notes were presented. Congratulations were passed to the Poole Association on the success of the SW Championships (particularly in financial terms). There was concern at the loss made on the Womens Development Tournament.
- Mr Richards expressed concern at the loss on the Referees Seminar he believed that a grant would be available from the Referees Commission to cover this loss. Mr Dingle to follow up this matter.

Thanks were passed to Mrs Sutherland re profit on coaches courses.

- d) Competition Secretary (Womens League) it was agreed that no entry should be accepted from TO Glos until they had paid their outstanding fines. Miss Swindell to contact Mr Giddy. Agreed that two Selkirk teams could be accepted in the same SW League.
- Mr Richards suggested that the ladies league be called the womens league.

 There was no agreement.
- (Mens League) Mr Hook asked if City of Cardiff had been fined for a late cancellation. Mr Giddy to be approached for an answer to this question.
- Agreed that Cardiff University would not be allowed to enter SW League.
- e) Coaching concern that while many coaches are being qualified there seem to be few registrations. Mr Hook suggested that more information was necessary on how to affiliate as a coach in particular clubs need to be chased up for coach affiliations.
- f)Officials Mr Williams asked if the Referees Sub Committee had met. Mr Dingle said that they had not. Mr Richards urged officers to use sub committees to share the planning and to bring draft plans to Executive meetings. Mr Dingle was concerned at potential cost of sub committees.
- g) Junior Development Officer. Mr Williams asked how it might be possible to find club places for good juniors. Mrs Sutherland was also concerned at the lack of opportunities for some of the players coming out of the junior squads.
