#### 5 Secretary's Report

A written report from Mr Richards had been previously distributed. He urged Area Secretaries to follow up the non affiliations.

## 6 Treasurer's Report

Mrs Dingle reported that the Associations finances were in a healthy state due to the grant which had been received from Sports Council and not yet claimed by Areas etc. However some large bills were anticipated for competitions, Administrative Conference, Junior Squads etc.

Mrs Dingle reminded members that they must provide full documentation and receipts when claiming expenses. Mr Reynolds agreed and stated that Sports Council auditors would carefully check accounts because of public accountability. He did however stress that it would be possible to transfer expenditure from one project to another with prior agreement from him.

Mrs Dingle informed members that all telephone calls could be itemised on BT bills.

#### 7 Competitions

No report had been received from Mr Giddy. Ms Swindell reported that the SW Womens League was being played without any serious problems.

## 12. EVA Regional Commission Representative's Report

A written report was presented by Mr Williams. January 29th. Mr Richards urged members to attend the EVA Strategic Conference on February 4th. Concern was expressed that Mr Dingle (SW Chairman) and Area Secretaries had not yet received an invitation or any information. Mr Richards to raise this with Mr Barstow / Mr Bulman.

#### 13. SWVA Development Plan

#### 13.1 Development Officer

Mr Richards provided information about the meetings that had taken place with representatives of SWVA, EVA, Sports Council and Northavon District Council.

The Job Description and Heads of Agreement were approved by the meeting. Mr Reynolds emphasised that the Development Officer could not do everything and it was important that the SW Executive Committee ensured that clubs and areas had realistic expectations of the Development Officer's ability to carry out a range of tasks - limited by time and funding. He suggested that it was not a good use of the Officer's time to spend all his / her time travelling in a car.

#### 13.2 Development Plan

Mr Richards listed the applications for grants so far received. He informed members that he had requested a revenue grant of £10,000 from Sports Council.

Mr Reynolds indicated that the grant might be nearer £7,000 depending on resources – but that this could not yet be confirmed. He suggested that SWVA looked at the applications received to date but that the full allocation of the grant to individual schemes could wait until further applications were received and the Development Officer was in post. He further suggested that SWVA might wish to "drive" some programmes with grant aid where areas were not able to provide programmes that would fulfil Development Plan targets.

The meeting accepted this proposal and agreed that Mr Richards, Mr Hook and Mrs Gillett should meet to discuss the existing applications, with an application to Sports Council by the end of February.

A paper from Mr Richards included a list of target areas in the Development Plan that were intended to be met by April 1996. These were discussed and additional points were noted:

Beach Volleyball - Mr Fairclough to be invited.

Dissemination - Mr Reynolds stressed the importance of clubs and areas having "ownership" of the plan.

## 15. European Youth Olympic Days

Mr Dingle reported on progress. Teams from Britain, Russia, Italy, Germany, Netherlands, Ukraine, Turkey and France would attend. Mr Dingle appealed for helpers to work at the event. A number of training weekends (29/30 April, 13/14 May, 24/25 June) were being arranged in Bath using national coaches - Mr Dingle to arrange with the EVA and Bath.

# 16. Volleyball Centennial

Mr Richards reminded members of the celebrations of 100 years of volleyball. He asked for areas to pass to him, and the EVA, information about any events they could run between April and June. Mrs Sutherland hoped to be able to run a Junior Beach Volleyball Tournament.

# 17 Date of next meeting

The next meeting will be a combined Executive meeting / AGM. It will take place on Saturday June 17th at Priory School. Discussion took place on the format of meetings and reports. It was agreed that Officers and Area Secretaries should be asked to provide reports to the Secretary for distribution prior to the meeting. As the next meeting is an AGM and full annual reports are required Mr Richards would wish to receive those reports by May 15th.

It is hoped that the Administration Conference will take place on April 2nd.

#### 18. AOB

Mr Richards provided information on the Youth sports Trust and "Top Club" - he urged members to become involved when possible - particularly if there was Champion Coaching Volleyball in their area.

Mr Stephens asked what the situation regarding Welsh clubs was regarding SWVA. Mr Richards explained that if clubs in S Wales affiliated to the EVA they automatically had SWV as their EVA region. Discussion took place on referee awards and Mr Richards will speak to Mr Goodman the Welsh Secretary concerning refereeing qualifications.
